THE BIDDERS ARE ADVISED TO COME PREPARED WITH A PRESENTATION OF 10 MINUTES EXPLAINING THEIR PAST EXPERIENCES AND A DETAILED WORKING OF MALHAR 2025.

ONLY TECHNICALLY QUALIFIED BIDS WILL BE ELIGIBLE FOR FINANCIAL EVALUATION.

2.
