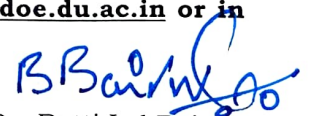

- I will not paste material on public walls, college property, or private property.
- I will remove campaign material in my name, promptly when required.

5) Campus Conduct
